Rules & Information

1. Entry forms including an entry fee of \$3.00 per item must be postmarked by February 6 and mailed to: Miller County Courthouse, 400 Laurel Street, Suite 215, Texarkana, AR 71854, by February 2TH
2. Previous entries are eligible with the exception of earlier Large or Small Best of Shows and Viewer's Choice winners. **The first 200 entries will be accepted.** Completed entry forms will be acknowledged by mail.
3. There are 3 days for quilt check in:
At Hancock's Fabrics, 3400 N. State Line
 - a. **Friday, Feb. 26, from 4:30-6:30**
 - b. **Saturday, Feb. 27, from 10am-12pm**And the Barbara Gleboff Fine Arts Building @ the Four States Fairground, Texarkana, AR on:
 - a. **Wednesday, Mar. 3, @ 8:00-9:30am.****You must present your verification letter at check in.**
4. Quilts must be clean and free of stains. No framed, tied, or matted quilts. The show committee reserves the right to re-categorize or reject any entry.
5. Each entry must be submitted in a fabric bag or pillow case. A label to be provided by the Quilt Board must be attached to the bag with 2 safety pins. **Only 1 item per bag.**
6. A 4" open ended fabric sleeve attached to the top of the back of each quilt is advised but not mandatory. A 2" sleeve is recommended for a little quilt. Each quilt must have a label to be provided by the Board attached (with 2 safety pins) to the bottom right side of the back of each entry. A sewn on label is also recommended.
7. Quilts will be judged and monies and ribbons will be awarded with the exception of the non judged category. Judging score sheets will also be returned with each entry. For a complete list of ribbons & prizes see our website.
8. A 15% fee will be charged for all quilts that are sold at the show.
9. A mail in program is available. Please see our web site for information.

10. Quilts are to be picked up at the Home Arts Building on the Four States Fairgrounds on Sat. March 6th @ 6:30pm. **Quilts will not be released without your verification letter.** There is no early checkout.

11. Participants mailing quilts please send them to Miller County Courthouse, 400 Laurel Street, Suite 215, Texarkana, AR 71854. Quilt mailed need to be in by Monday, March 1.
